

AND WHEREAS the settlor/founder/author is interested and desirous to create an educational and welfare trust in order to promote and encourage general and technical education in the society and to make proper arrangement to educate the people/student of the society and to do general welfare works for the people of the society. And whereas in persistence of the said desire and for carrying out the same into effect and the settler named above has settled presently a sum of Rs. 11,000/- (eleven thousand Only) to begin with the extending humanitarian services including educational or any activities of general public welfare. The trustees by way utilize trust fund with an assurance to donate and manage the further amount, if and when the same would be required and as would be possible and convenient to the settler/founder/author.

AND WHEREAS the trustees will utilize the fund of the trust including all accumulation and accretion therein the manner and for the purpose hereinafter mentioned.

NOW THIS DEED / INDENTURE WITNESSETH AS FOLLOWS:

(1) Name:

The name of the Trust hereby established shall always be "H.R. MEMORIAL EDUCATIONAL AND WELFARE TRUST" and the same shall never be changed.

(2) Office:

The Principal office of the trust shall be at "SHIVPURI COLONY, JOGHADIH MORE, P.O. + P.S.- CHAS, DIST- BOKARO, JHARKHAND, PIN- 827013".

(3) Jurisdiction:

The Jurisdiction of the Trust shall be the State of Jharkhand only.

(4) Properties:

The Trust properties shall consist of-

(a) The amount Transferred by the SETTLOR as mentioned above, towards the corpus fund of the Trust.

(b) Any cash or kind, properties, movable and immovable that may be acquired by purchase or otherwise or all manner of rights, title or interest in or over any property movable or immovable.

(c) All additions and accretions to the Trust properties and the income there from.

(d) All donations, gifts, legacies or grants, in cash or kind accepted by the Trustees upon trust.

The properties of the Trust shall be utilized for the objects set forth herein above and subject to the provisions and conditions herein mentioned.



(5) Aims and Objectives:

The aims and objectives for which the trust is created and for which the trust fund may be utilized are as follows:

- (i) To establish, maintain and run schools, colleges, social service centres, Industrial training centres and vocational training centres.
- (ii) To open, establish, manage, control and run schools from nursery to Higher secondary standard, Degree and Post graduate colleges, Teachers Training Colleges(B.Ed., M.Ed., D.Ed., B.P.Ed., etc), Engineering colleges, Polytechnic colleges, I.T.I. Colleges; Medical colleges, Hospitals & Research Centres; Nursing colleges, Law college, Business Administration College, Computer Application Colleges, Pharmacy Colleges, e-learning centre, Mass media Communication, Journalism, Para medical colleges, Environmental Education Courses, International Schools, and other associated institutions.
- (iii) To support, assist or grant aid or other financial assistance to schools, colleges, libraries, laboratories, educational or other institution of India, for use of the students and the staff and also for the development, advancement of education and diffusion of knowledge amongst the public in general.
- (iv) To educate and give financial or other assistance in kind by way of studentships, scholarships, stipends, medals, certificates, distribution of books, notebooks, cloths, uniform, or meals for the poor and indigent (SC/ST/BC/Physically Handicapped, economically weaker section of the society) and to the persons suffer due to natural calamities at free of cost.
- (v) To advance Indian Culture and Literature in order to work on few social obligations like women empowerment, woman harassment, abolition of child marriage, bad customs and dowry system; Old age homes, Orphanage, School for orphans, blinds, physically handicapped children, zero addiction to drugs and alcohol programs, etc.



- (vii) To provide free education to intelligent and poor students; organize job training and provide jobs for illiterate women, etc.
- (viii) To organize educational campaigns, free medical check-up camps, programs on AIDS, vaccination, etc.
- (ix) To make proper arrangements for safe drinking water, hygienic food and sanitation, solar power for villagers.
- (x) To establish and provide assistance for Ponds, Check-dams, hand-pumps; and also for sericulture, Fishery culture, Poultry, piggery, Anganwari Kendra, Basawari Kendra, etc.
- (xi) To train teachers and workers in ideals and practice of the true spirit of the education and learning.
- (xii) To undertake propaganda, training and education of the masses either of its own or in co-operation with similar agencies working for the cause of all round development of the Society.
- (xiii) To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- (xiv) To establish centres for employment generation and Distance Education (IGNOU).
- (xv) To establish environmental study centre (Especially for control of environmental pollution; and also for afforestation).
- (xvi) To establish study centre for control of rain water for its maximum utility through different water harvesting system.
- (xvii) To establish the colleges to impart education in the area of higher education especially the emerging field like, Electronics, Bio-diversity, Biotechnology, and other Agriculture based Higher Education.
- (xviii) To arrange and organize guest lectures, debates, discussions, study tours, conferences, or radio-talks, TV coverage, for the advancement of the objectives of the trust.



- (xviii) To organize and run schools, colleges and University (Private or Deemed university) which will be affiliated to State Govt/central Govt/University/UGC(whichever applicable) and recognized by CBSE/Council/UGC/ICSTE/AICTE/INC others within India and abroad in order to serve the weaker section of the society.
- (xix) The source of income of the trust/institution may be tuition fee, subscriptions, donations and special contributions. The Trust may raise funds through donations and special contributions to support all the above activities, and setting up appropriate management structure, including subsidiary units as necessary.
- (xx) Create assets and transport facilities to accommodate any of the above activities.
- (xxi) To serve the people of this state and also the area of work of this trust will extend to other states of India.
- (xxii) To receive and collect any gift, aid/grant, scholarships from government and non-government organizations, subscription and donation either in cash or in kind or by way of any lawful means and spend the same for the fulfillment of all or any of the aims and objectives of the Trust. The income and properties of the trust shall be spending safely for the generation and fulfillment of all or any of the aims and objectives of the trust.
- (xxiii) To acquire assets by purchase or by gift or to take on lease, hire, or otherwise hold any movable or immovable properties or any right or privilege that may be deemed necessary or useful for the advancement of the objectives of the Trust.

(6) BENEFICIARIES OF THE TRUST:

The Trust is established for the benefit for the humanity and the class of people mentioned above without discrimination of caste, religion, creed or sex.


(7) Trust Administration and Power of the Board of Trustees:

(A) The Board of Trustees shall have power to:

- (i) To administer the Trust, its properties and affairs and do all the things which will fulfill the performance of the objects for which the Trust is established and for this purpose the Board can apply the whole or any part of the Trust property towards the payment of the expenses of the Trust.
 - (ii) To see that the income and the properties of the Trust is solely utilized towards the objects of the Trust and no portion of it is utilized for payment to the Settler, or Trustees or their relatives by way of salary, allowances, profit, interest, dividend etc.
 - (iii) The number of trustee shall at no time be less than three and more than eleven.
 - (iv) To invest the Trust funds in the manner not prohibited by any provisions of the Income Tax Act, 1961.
 - (v) To buy, sell, mortgage, grant, lease, hire or otherwise alienate all or any of the properties of the Trust in its discretion for adequate consideration, so however any sale or alienation of immovable properties of the trust can be done only after obtaining the prior approval of the Commissioner of Income Tax. To buy or to take on lease, land and other movable or immovable properties, shall be in the name of trust or in the name of the institution, as per the decision of the board of trustees or as per the requirements of the affiliating body.
 - (vi) To execute power of attorney or powers of attorney to any person for the purpose of executing, administering or managing the whole or any part of the Trust for the purpose of all or some among the objects of the Trust.
 - (vii) To receive donations and voluntary special contributions from any person or persons, any organization, association, trust and NGO from India or outside, after complying with the statutory formalities, by way of donation, gifts or in any other manner and to hold the same upon Trust for the objects set forth herein.
 - (viii) To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out the objects of the Trust.

- (ix) The Board shall have power to make and quash rules and regulations for the management and administration of the Trust.
- (x) No Trustee shall commit any act or breach of Trust of the Trust fund or property or cause any loss to the Trust property or commit fraud in the administration of the Trust fund / property.
- (xi) The Trust can form a Managing Committee with members from outside of trustees shall be for a period of three year from their date of formation of the committee and they may be reelected for further terms. The purpose of the Managing Committee is to manage, run and administer the Institutions established by the Trust. The managing committee may be the same or different for other educational institutions of the trust.
- (xii) The Trustees shall hold honorary office and shall not be entitled to any Salary, allowances or perquisites, except for the reimbursement of actual expenses incurred in connection with attending to the Trust matters.
- (xiii) The Board of Trustees will follow the instructions given by any donor who makes substantial contribution towards furtherance of the objects of the Trust, so long as such instructions are not detrimental to the attainment of the objects of the Trust and are in conformity with the provisions of the Income-tax Act, 1961.
- (xiv) The Trustees shall select from among themselves Vice-President, Secretary and Treasurer. No Trustee include the Managing Trustee shall hold more than one post of above offices at the same time. The persons holding these offices of Vice President, Secretary and Treasurer shall be under the administrative guidance and supervision of the Board of Trustees and will report through the Managing Trustee.
- (xv) The founder namely Dr. Chandi Charan Mahato shall be the Managing Trustee and Chairman of the Trust.
- (xvi) The Trustee namely Kundan Kishore shall be the Secretary of the trust.
- (xvii) The trustee namely Sawan Ram Mahato shall be the Treasurer of the trust.

(B) ROLES, RESPONSIBILITIES AND POWERS:

The Roles, Responsibilities and Powers of all these office bearers are defined below. In addition to these, the Board of Trustee may grant additional roles, responsibilities and powers to any of the Trustees as and when required.

(i) MANAGING TRUSTEE / PRESIDENT:

In addition to discharging normal duties of a trustee, the Managing Trustee/President will be organize meetings under the his chairmanship and sign all documents, including bank documents, acknowledgements for the contributions received, and agreements with individuals, government institutions and other organizations on behalf of the Board of Trustees upon the decision of the Board for each and every case. The managing trustee/ President have power to certify the documents produced by secretary and the board of trustees. The Managing Trustee/President along with the Board of trustees is responsible for ensuring that the Trust pursues its objects and for maintaining the dignity of the Trust organization and shall use his/her influence to promote the activities of the Trust. In the event of equality of votes, the Chairman presiding over the meeting shall have a casting vote.

(ii) VICE-PRESIDENT:

The Vice President shall discharge the duties of the Managing Trustee/President, in the absence of the Managing Trustee/President of the Trust.

(iii) SECRETARY:

The Secretary shall maintain the records of the organization, prepare and circulate agenda and minutes of Board of Trustees meeting. The Secretary shall be also responsible for the day to day administration activities of the Trust. The Secretary shall deal with correspondence received by the Trust, send replies in consultation with the Managing Trustee/President, Vice President and/or the Treasurer where necessary. He/she is responsible for the safe custody of all the assets and records of the Trust. The Secretary shall represent the Trust in all legal matters, sign the papers related to legal cases, attend to courts or represent the Trust in Government offices. In addition to discharging normal duties of a trustee, the Secretary will be authorized person to sign all documents, including bank documents, acknowledgements for the

contributions received, and agreements with individuals, government institutions and other organizations on behalf of the Board of Trustees upon the decision of the Board for each and every case.

The Secretary is authorized to sign bank cheques, application for drafts and payment instructions jointly with the Managing Trustee/President or Treasurer and draw money from the bank, up to the limits defined by the Board of Trustees in their meetings. The Secretary is responsible for safe custody of cash, bonds, securities etc. of the Trust.

(iv) TREASURER:

The Treasurer, in consultation with the Managing Trustee/President and Secretary, will prepare Annual Budget, monthly and yearly expenditure statements, and get the expenditure audited by auditor (duly decided by the Board of Trustees) and place them before the Secretary for approval. The Treasurer is responsible to maintain cash book and prepare monthly and yearly statements of revenue and expenditure, as well as, the maintain the records of assets of the Trust and place them before the Board of Trustees for their approval. The treasurer has the power to expense up to 1000/- (One thousand rupees only) without prior approval but in the subsequent meeting he will take approval from the board of trustee.

(5) MEETING OF THE BOARD OF TRUSTEES:

The Board of Trustees should meet at least once in every calendar year and may meet more often when required.

- (i) The meeting of Board of Trustees shall be convened by the Managing Trustee/President. In his absence, the President may authorize the Secretary to convene such meetings. Any member of the Board of the Trustees can call for a meeting.
- (ii) One half of the Board of Trustees or a minimum of three trustees, whichever is higher, shall constitute the QUORUM for the Board of Trustees meetings.

(iii) All decisions shall be carried out by the majority decision of the Board but in the event of equality of votes, the Chairman presiding over the meeting shall have a casting vote.

(iv) Any resolution in writing signed by all the Trustees by circulation shall have equal force as though it has been passed at a meeting of the Board of Trustees.

(v) The meeting of the Board shall be convened after giving at least a week's notice unless all the Trustees agree to accept a shorter notice.

(vi) The Board of Trustees may invite other persons interested in the objects and functioning of the Trust to attend the meetings of the Board, but they shall not be entitled vote in the meetings of the Board.

(ii) BANK ACCOUNT:

a) The Managing Trustee/President, Secretary and the Treasurer shall jointly operate Bank Accounts on behalf of the Trust/institution. The payments are always made through cheques in which signature of two person is compulsory, in which signature of Secretary is mandatory.

One or more Bank Accounts may be opened in any Bank and or Banks in the name of the Trust anywhere to carry out the objectives of the Trust.

b) The Managing Trustee/President, Secretary and the Treasurer may open Sub-Bank Account with its main bank account.

(iii) INVESTMENT OF TRUST FUNDS:

(a) The Board of Trustees shall have the power to invest the funds, assets and properties of the Trust at their discretion in accordance with the provisions of the Income Tax Act, 1981.

(b) The Board shall also determine from time to time, the amount it shall spend on the various activities of the Trust.

(c) The receipt of the trustees for any moneys, stocks, funds, shares securities, or investments paid, delivered or transferred to them in execution of the trust of powers thereof, effectively release and discharge the person or persons, delivering or

transferring the same, and from seeing or from being bound to see to the application or being answerable for any loss or misapplication thereof.

(d) The trustees shall be respectively chargeable only for such moneys, stocks, shares, funds and securities as they shall actually receive notwithstanding their respectively signing a receipt jointly with others for the sake of conformity and shall be answerable and accountable for their own accounts receipts, neglects, and defaults respectively and shall not be answerable either one for the other or others of them or for any banker, broker or the person with whom or into whose hands any trust money or securities may come or be deposited or for the insufficiency or deficiency of any stocks, funds or other securities or for any other loss unless the same shall happen through their willful default or negligence.

(11) ACCOUNTS AND AUDIT:

- a) The financial year of the Trust shall be from beginning and end of academic session of the institution of the following year, unless otherwise decided by the Board of Trustees.
- b) The Board of Trustees shall maintain true and correct accounts of the Trust.
- c) The trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in the course of the management of trust properties or in relation to carrying out the objects and purposes of the trust as well as of all the assets, liabilities, credits and effects of the trust properties.
- d) The accounts of the Trust shall be annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statement of account shall be placed before the Board for its approval within three months of the close of the financial year.

(12) AMENDMENTS:

While this Trust shall be irrevocable, the Board of Trustees may amend any of the clauses except those relating to objects of the Trust. The First Trustees, at a duly convened meeting of the Board with at least 2 weeks' notice, and by a resolution

passed by at least three-fourths majority of the Board of Trustees. The amendments to the Trust Deed can only be passed by a resolution of the Board of Trustees in an actual meeting and not by circulation.

(13) INDEMNITY:

The Board of Trustees shall be indemnified for any act done by them in good faith in the course of the administration of the Trust.

(14) APPLICABILITY OF TRUST ACT:

The provisions of the Indian Trust Act 1882 shall apply to all matters.

(15) APPLICATION OF INCOME TAX ACT:

All clauses herein are intended to secure exemption from Income Tax on the income of contributions and donations to the Trust and any clause or portion of this Deed of Trust which is inconsistent with or repugnant to the sections of the Income Tax Act, 1961 as amended, substituted or modified from time to time, shall be deemed to be deleted or modified with effect from the date on which the sections to which the clause or part of a clause is repugnant or inconsistent comes into force.

(16) THIS TRUST IS DECLARED IRREVOCABLE.

(17) DISSOLUTION:

In the event of dissolution of the Trust, the entire Trust funds shall be realized and first be used for payment of liabilities of the Trust. The assets left if any, shall be disbursed to any other Trust, which have similar objectives, after obtaining approval from the Commissioner of Income Tax.

(18) SCHEDULE OF THE TRUST:

At present, the Trust has no property or assets, either movable or immovable, other than the Trust Fund and the immovable properties, donated by the SETTLER, as described in the Schedule below:

1. Cash contribution to the Corpus Fund of the Trust of Rs. 11,000/- (Rupees Eleven Thousand only).
